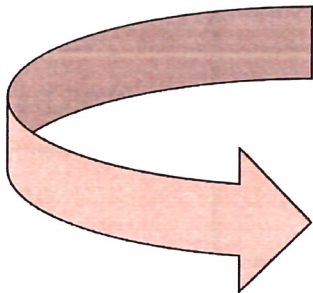

School Meals During the Pandemic

When COVID-19 closed schools in March 2020, school nutrition professionals quickly adapted operations to ensure hungry students continued to have access to healthy school meals. Thanks to federal regulatory waivers, schools, including Hancock County Schools, offered free meals to all children through the Summer Food Service Program (SFSP) and Seamless Summer Option (SSO). We delivered directly to student homes or along bus routes.

As students returned to school, waiver extensions allowed us as school nutrition professionals to continue to safely serve students as they were learning in person. Schools implemented new food safety and sanitation procedures and enforced social distancing during meal service to minimize contact between students and staff. Offering free meals to all students sped up meal distribution and improved safety by eliminating requirements for staff to collect payment or verify student eligibility for free meals.

SY 2021/22 waivers allowed school meal programs to maintain grab-and-go meals, pandemic safety measures and free breakfast and lunch for all in person and remote learners through SSO. However, SNA's Back to School 2021 Survey finds school meal programs still face significant concerns, including continued pandemic supply chain disruptions and staff shortages, financial and regulatory challenges. *(SNA's School Meal Trends & Stats)*
